Quilt Expo Sit & Sew Workshop Sponsorship recognition and opportunities include but may not be limited to those items outlined on the Sit & Sew Workshop Sponsorship Recognition and Opportunities page.

The final decision regarding placement and/or juxtaposition of sponsor(s) shall rest with Quilt Expo.

When future Quilt Expos are scheduled, The Sponsor shall have the right of first refusal on continuing its sponsorship of this event.
